League Update

- 129 schools after 1.5 years of inactivity; almost same numbers of women's school teams
- Religious Exemption discussion, player can't play Friday sunday to Saturday Sundown: ask legal counsel **ACTION ITEM**: ask Karen; SS states we need to be consistent to apply the logic universally
- Upstate NY Central to Upstate NY West for this year
- UBC will be RSPW in the West region specifically in Northern California; University of Oregon will be refunded this year for NCTTA since PNW is not large enough for a division
- Eligibility forms are given directly to info@nctta.org in Spring semester we will use a different email address; new NCTTA app page allows for group eligibility or individual eligibility (needs to change directions on the form) ACTION ITEM: WL to change so that DD's can forward form ASAP to central email

- ITTF contacted NCTTA for volunteer/commentator help,
- USATT not involved, odd.
- we gave them commentators that worked with NCTTA: (Barbara Wei, Roger Dickson, Andy Nguyen, Logan Zimmerman) these ppl will be working with ex NCTTA'er Adam Bobrow!

Champs and Champs banquet update

- JEW put up a Banquet Checklist; still looking for another catering vendor, is getting help from RR cvb with new leads
- Embassy Suites which could be a possibility for banquet is still in the mix, though outside event is still probably less expensive, though more legwork
- Banquet Checklist includes: Venue, Caterer, DJ, Chairs, Riser, Podium, portable lights, etc; JEW is still working on getting everything in shape
- Video presentation that is done at the Banquet is a question mark on how to do it, how to present it--outdoor venue is the covered parking lot; need a projector, big screen; hard to have a decent digital presentation outside

Spectators or no Spectators

- No spectators we don't have to deal with extra volunteers to take money, though we
 would have to hire security so that no one except coaches, players, volunteers enter
- Having Spectators adds added complexity if we are asking volunteers, players to do
 a negative PCR test and then spectators are just free to come in as they are
- Without any spectators we can get more room in the facility

Volunteer report

- WL is still working with the TX people for volunteerism
- The goal is to fill our championship volunteer pool with local help vs people that have to fly in with the exception of our "key staff"
- Mental Health area is only 400 dollars and a laptop and we are needing a conference room for this: ACTION ITEM: asking Courtyard to see what is what for 3 days business hours to get a comp space and a laptop, get Shelly involved

Storage for future

- What are we doing with our equipment after the championships?
- Who is going to move all of this stuff and how?
- We will have to get another bigger room in the future for storage too b/c the tables will be set up
- **ACTION ITEM: Randy** to get a bigger room for Round Rock in April 2022
- Move #1: Moving 700 barriers in boxes; 35 tables in boxes; 2 rolls of flooring from Round Rock Storage to Round Rock Sports Center; 9 minutes drive away? How, who helps
- Move #2: Moving built barriers, tables and floors back to Round Rock Storage on Monday after champs
- Move #3: Eventually moving all (barriers, tables, umpire tables, and flooring and our stuff from Ed) to the next Championship location
